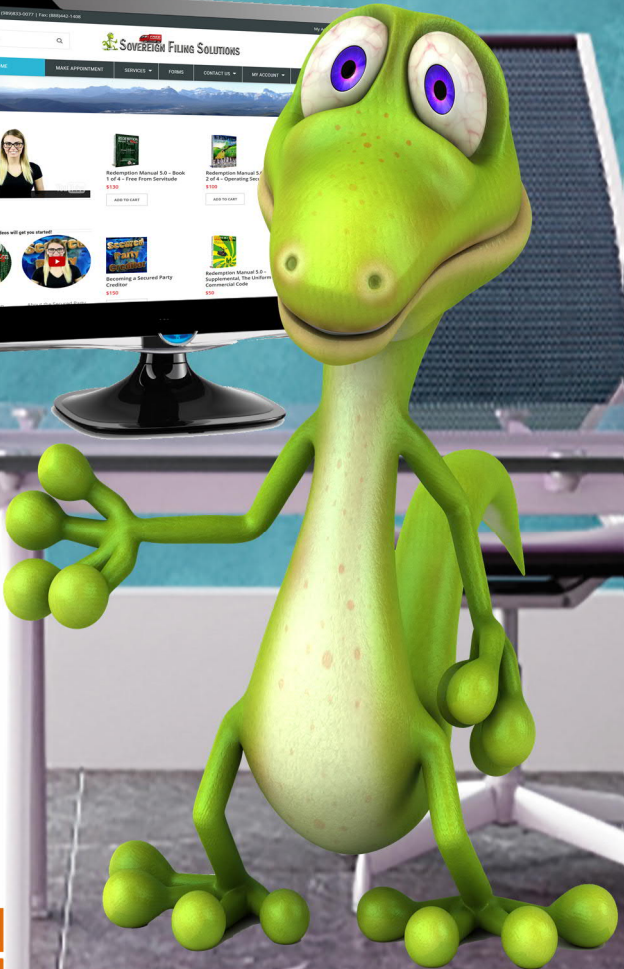

I the undersigned principal, a natural man, and inhabitant on the Land in the original jurisdiction of this States Republic, do hereby designate Sovereign Filing Solutions as attorney in fact to act in the following capacity in my behalf:

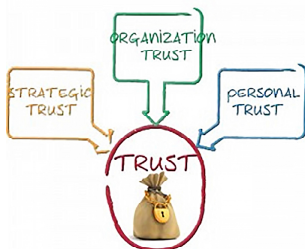

## **An Business Organization Trust (BOT) is:**

1) an organization created and managed by "trustees" for the benefit and profit of Beneficiaries who hold or may acquire transferable trust certificates. Trust certificates provide individual holders evidence of interest in the Trust estate (assets/income).

2) A powerful entity by which individuals may combine their resources to operate a business for profit without the inherent liabilities of a partnership or the double taxation of corporations. A BOT. can preserve privacy; protect assets against judgments and lawsuits.



3) Often called a "Common-law Trust" but this phrase is not descriptive of any of the peculiar characteristics of such organizations. The basis for the terminology "Common-law Trust" is that they are created under the common law of contracts and does not depend upon any statute for its existence. See the United States Constitution, Article 1 Sec. 10, Clause 1

4) brought into being by: a Declaration of Trust. This document makes all the provisions of who is who and who is responsible for what, relative to the Trust activities.

5) A great way to avoid tax liabilities of a business, or trust transactions, until money or assets are distributed to the beneficiaries.

1) Privacy, 2) Limited liability, 3) Not subject to probate, 4) No state or inheritance taxes, 5) Minimize and/or avoid income taxes, 6) Maximize depreciation, 7) Reduce capital gains tax, 8) Separate investment program, 9) Protect Assets against Creditors

# Frequently Asked Questions

## Where do I begin?

The Secured Party Creditor process is the generally the beginning of all the processes. Please read on for more information.

## What is a Secured Party Creditor?

A Secured Party Creditor (SPC), means that you have made the declarations for freedom and also put them on public record and that they have gone unrequited. As well that you have laid the foundation of understanding and knowledge and have taken 'control' of the Debtor/Entity and all property in the Debtor's name; accounts, Birth Certificate, later the Home/land, automobiles, and like property, all accounts, pets, stock animals, your children's debtors, etc., etc. You are showing separation between the commercial fiction and the living breathing human being. This is first and major step in establishing your freedom as it rebuts the pre-assumed assumptions that will otherwise be made on your behalf. Furthermore as an SPC you have preserved your interests and are in a better position to state a claim.

## What are the benefits of being a Secured Party Creditor?

There are many benefits of being an SPC, one is the aspects of protections that it offers, another is the statements of fact that you make that become public record, and even the discharge abilities that some utilize with great success. Although we do not get into discharge processes or discuss them because of internal policy there is more information available for you to study on your own of you would like at [www.SovereignConnection.com](http://www.SovereignConnection.com). Please note that if discharge or money is the only leading factor for your decision to become a Secured Party Creditor then you are not only going to have to invest a great deal of time in study, but also that the processes are not easy or simple, nor can we help you on this path. These processes are not for everyone, and your greatest strength will be your knowledge.

## Can I change my name through the SPC process?

The short answer to this is yes, but in use there are some qualifications that you should be aware of. If you would like your secured party creditor name for future use and better separation between debtor and secured party it can be done by using a different name on the "Necessary Information for Filing" form. Many as they are born again undergoing a "spiritual rebirth" choose to use a new name as has commonly been done throughout history. In many ways this is a religious right. The DEBTORS name on the other hand CANNOT be changed as it will always be the name on the birth certificate that was assigned at birth. There are some issues that arise in name changes such as identification and ability to use "Government ID" under the new name. We would strongly suggest not doing so as it is reentrance into contract (invisible/implied in nature) to do so. On the other hand, we do offer identifications that reference the filing that is put in place that may be of great use to you. As well through common use it will not be an issue as you adjust to the change. The only other issue, one we see as a benefit, is that there is not a SSN associated with the name thus it is difficult to open bank accounts. This is still accomplishable if necessary with proper knowledge and understanding. A great place to start is the book Operating Sovereign.

## How long does it take to complete the SPC process?

It depends on the package type, if you get the You File package then our commitment to you ends in about a weeks time as we are solely drawing up the documentation for you. For the We File or the We File & Notaries Package it generally takes between 4 and 12 weeks to complete. There is an expedited package available where the process can be completed in as little as 3 weeks but you must fill out and make payment online.

## What Addresses should I use on the Necessary Information for Filing? Should I used separate addresses?

You should most definitely use separate addresses for both the debtor and secured party as to create as much separation between them as possible if you are able to do so. The Secured Party's address is best a P.O. Box or an address that is not your primary including that of a foreign receivership, while a tangible address such as that of a home, apartment or secondary home should be used for the DEBTOR. While it

is not mandatory, it is recommended.

## **How long after I submit payment and the necessary information will it take to get my filing to me?**

This of course is dependent on the filing itself. Generally though if your documentation and payment are submitted by mail a draft copy for proofing will generally arrive via e-mail within 48 hours for you to review and go over for corrections after we have received and processed your mail. If you submit your filing and payment online and then call sales at extension 2 it is possible to have your proofing copy to you within 15 minutes.

## **What is CAFV?**

CAFV short for Conditional Acceptance for Value is a 'private letter process', your basic Private Administrative Process to resolve a matter or to get agreement from your other party to, let's say, to agree to the discharge of debt, or that you are not subject to the statute, etc. It is part and parcel of the 'Remedy' as referenced in UCC-1.201 (34) "Remedy" means any remedial right to which an aggrieved party is entitled to with or without resort to a tribunal. If you get their agreement there is no controversy. The agreement/contract is the law! The CAFV is a very powerful administrative process used to establish facts for the record, and is done in accordance with rights upheld in the constitution, international law, FRCP rule 36 and 26 (b)(1) and/or applicable state statutes. It is done in such a way to create the largest range of use, from entirely administrative processes such as collection of debts, or proof of inapplicability, to admissibility in court if it is decided that you would like to use it in such a way.

## **Can you help me with Discharge Processes/ Discharge of Debt?**

## **Can you be my General Power of Attorney / How can I accomplish the processes?**

We cannot be your general power of attorney for signing documents but do require a POA to act as agent on your behalf for creation/sending. With such said if you do not have direct access to everything that you need or are facing hurdles that would restrict your ability to do so we suggest that you appoint a General Power of Attorney. The processes can be completed from about anywhere or by anyone even if they do not have to ability to access everything directly by appointing a general or durable power of attorney to act in their stead. Generally this appointment is made either to a family member or close friend that can be trusted and is willing to follow through in your stead in coordination with Sovereign Filing Solutions. A general POA for this purpose can be found for Free and printed from our website by looking under the Forms section or requested by mail using the check form at the end of this FAQ.

## **Can you obtain my Birth Certificate or Social Security Card for me?**

We do not offer either of these services nor can we as it may be seen as a conflict of interest. This is something that either you or your power of attorney need to accomplish. We can offer suggestions though, such as where to find proper forms to do so. By far the easiest way to do so is to do a Google search for Vital Statistics "State Born In". So if you were born in Tennessee you would lookup "Vital Statistics Tennessee". Another suggestion we would offer is to use the mail order form with a physical address that is not that of an institution or business. Such as a home address of yourself or that of your Power of Attorney. If you attempt to have your Power of Attorney go in person on your behalf this in almost all cases will not work and will place the issuing authority on alert. So if you yourself are not able to go in person then the second best option is the mail order form.

## How do I make purchases if I do not have access to the website?

If you can use a friend or family member to file online it is strongly recommended. If that is not an option and you are making purchases and are not doing so on the website then please make sure you include a concise cover letter with your money order as to what the funds are submitted for as well as any comments or instructions that may be pertinent to what you are making payment for and your contact information.

"A lawyer cannot claim that you have rights." *U.S. v. Johnson*, 76 F. Supp. 538

The American Bar Association does not even recommend the use of a lawyer except in dangerously precarious situations as they state in their Q&A. Q. If I do not use a lawyer, who else can help me? A. Unless your problem is so serious that only a lawyer can resolve it, you should first consider another source of help.
